

PUBLIC NOTICE TO ALL CUSTOMERS OF THE TWO RIVERS WATER AND LIGHT UTILITY

The Two Rivers Water and Light Utility (Utility) has filed an application with the Public Service Commission of Wisconsin (PSCW) to increase water rates. The increase is necessary due to a 20 percent increase in gross plant investment and a 3 percent increase in operating expenses since the last water rate case was completed in 2010. The increases in gross plant investment includes \$1.6 million in new mains, services, meters and hydrants.

The total increase in water revenues requested is \$288,057 which will result in an estimated overall rate increase of 12 percent over the water utility's present revenues. If the request is granted, the water bill for an average residential customer with a 5/8-inch or 3/4-inch meter who uses 400 cubic feet of water per month will increase from \$26.15 to \$28.70, or 10% (not including the public fire protection charge), and will increase from \$33.65 to \$38.25, or 14% (including the public fire protection charge).

The PSCW is requiring that the Utility hold a second public hearing to address the recovery of costs for approximately 1,900 Automatic Meter Reading (AMR) meters installed by the Utility prior to receiving PSCW authorization.

The second telephonic public hearing on the application has been scheduled for Wednesday, June 13, 2018, at 1:00 p.m. in the Two Rivers City Hall, 1717 E. Park Street, Two Rivers. Scheduling questions regarding this hearing may be directed to the PSCW at (608) 266-3768.
