Mr. Barbier introduced himself and thanked the City for the opportunity to join the Two Rivers Fire Department. He was sworn in by the City Clerk and signed his oath of office.

2. Introduction of Acting Captain Zach Peterson, Fire Department

Fire Chief Steve Denzien introduced Firefighter Zach Peterson and congratulated him on his promotion to Acting Captain. The Acting Captain vacancy was also created by Mark Guehlstorf's retirement.

- 2. Redevelopment Project at Washington and 12th Streets (Former M&M Lunch and Adjacent Property)

Mr. Buckley reported on the proposed redevelopment project at Washington and 12th Streets. The amendment to TID #12 is before the Council tonight for approval with final approval by the Joint Review Board on Tuesday, February 16th at 3:00 p.m. A development agreement and authorization for borrowing is expected to be ready for presentation to Council in March.

 - Mr. Buckley reported on the Two Rivers Main Street Facade and Sign Grant Program. Applications have been distributed to all property and business owners in the downtown Business Improvement District. Applications are due by April 15.

Mr. Buckley reported that the City storm water ponds are collecting at or above the amounts of solids projected by the models. Also, testing of the sediments revealed no significant issues with contaminants like metals; it is likely that solids from the ponds could be land-spread, versus landfilled.

- b. Upcoming Regulations Based on Total Maximum Daily Loading (TM DL) Mr. Buckley reported on upcoming regulations based on Total Maximum Daily Loading (TMDL). TMDL is the calculation of the maximum amount of a pollutant allowed to enter a water body so that the water body will meet and continue to meet USEPA water quality standards for that particular pollutant.
