Mr. Buckley stated that WI State Statutes allow the use of a secret ballot where a public body is electing its officers. He asked for nominations for President. Councilmember Bittner nominated Curt Andrews and Councilmember Remiker nominated Adam Wachowski. There were no other nominations, therefore, nominations were closed.

On a vote of 6 to 3, Curt Andrews was declared President of the City Council.

Council President Andrews assumed the Chair and called for nominations for Vice-President. Councilmember Shimulunas nominated Jay Remiker, Councilmember Wachowski nominated Jeff Dahlke, Councilmember Bittner nominated Darla LeClair, and Council President Andrews nominated Adam Wachowski. There were no other nominations, therefore, nominations were closed.

Paper ballots were distributed and votes were cast for all four nominees. Jeff Dahlke received the lowest number of votes and was eliminated. Paper ballots were then cast again for the three remaining nominees. Jay Remiker received the lowest number of votes and was eliminated. Paper ballots were then cast again for the two remaining nominees. On a vote of 5 to 4, Adam Wachowski was declared Vice-President of the City Council.
