### PUBLIC NOTICE CITY OF TWO RIVERS SIDEWALK SNOW & ICE REMOVAL

NOTICE IS HEREBY GIVEN TO PROPERTY OWNERS, LEASEES, AND OCCUPANTS that snow and ice shall be removed from any public sidewalk within 24 hours from the time when the snow ceases to fall. For corner lots, this includes the sidewalk and any ramps. If such snow or ice is not removed, the City Manager or City Engineer may cause such to be removed. The City shall bill the cost of such removal to the property owner and, if said bill is not paid by the property owner, shall insert such cost in the tax roll as a special tax and lien against the premises.

The cost of such removal shall include the City's reasonable costs for establishing an incident report/file for the violation, for site inspection and documentation of the violation, and for producing and mailing the related billing, in addition to the labor, equipment and material costs incurred in clearing the sidewalk of snow and/or ice.

Blowing or depositing snow or ice in the street is against the law. Offenders are subject to fines in accordance with the Two Rivers Municipal Code 4-1-12 The Police Department or the City Engineer may enforce this section.

## THINKING OF RUNNING FOR OFFICE IN 2023?

Individuals interested in running for City Council in the April 2023 election can pick up candidacy and nomination paper packets in the City Clerk's office starting December 1, 2022

The three Council seats that will appear on the April ballot are currently held by Bonnie Shimulunas, Adam Wachowski and Darla LeClair, all of whom are eligible to run for re-election if they choose.

Two Rivers City Council Members are elected "at large" that is, they are voted on by, and represent the entire city. Council terms are three years.
