STREET TREE PLANTING PERMIT APPLICATION

In addition to the specifications set forth in the City of Two Rivers Policies for Pruning and Removal of Street Terrace Trees, the following special provisions are considered part of this agreement and shall be adhered to as part of this Planting Permit.

- 1. Trees must comply with the following spacing:
 - a. 30 ft. from any street corner
 - b. 10 ft. from a driveway
 - c. 20 ft. from a streetlight
 - d. 10 ft. from a fire hydrant
 - e. 10 ft from a gas/water valve
 - f. 20 ft. from a utility pole
- 2. The homeowner is responsible for contacting Diggers Hotline prior to planting any trees.
- 3. Terrace trees shall be planted equal distance between sidewalk or proposed sidewalk and back of curb or proposed curb in coordination with underground utilities.
- 4. All trees shall be planted in line with each other at a spacing between 30 ft 50 ft. depending upon the species of tree and approval of the City Forester.
- 5. Trees may be allowed on terraces less than 4f t. wide with the City Forester's approval, but trees are prohibited in right of ways less than 50 ft. wide.
- 6. No planting of shrubbery, ground cover, or other plants within the terrace area.
- 7. Trees shall not be less than one and on half inches (1 ¹/₂) in diameter at six inches (6") above the ground.
- 8. Street tree species shall be determined and/or approved by the City of Two Rivers Parks and Recreation Director prior to the start of work.
- 9. The planting hole shall be a minimum of twice the diameter of the ball, with sides sloping inward toward the bottom of the root ball. The planting hole shall not be dug deeper than the root ball and the root ball shall not be placed on undisturbed sub-soil.
- 10. The root flare of the tree shall be placed at or not more than on inch (1") above the grade of the surrounding soil. Balled and burlapped and potted and trees shall have excess soil removed from the top of the root system to ensure the root flare is properly located.
- 11. All burlap wrapping, strings, wire baskets and nails shall be removed from the upper half of the root ball after the tree has been placed in the planting hole.
