## Call to Order

The meeting was called to order by Chairperson Patrick Gagnon at 6:00 PM.

## Roll Call

Committee Members present: Kay Koach, Patrick Gagnon and Jack Powalisz.

Also present were: Gregory Buckley, City Manager; Dave Buss, Finance Director; Scott Schneider, Fire Chief.

## Overtime Hours and Pay Analysis, December 2017

The Committee reviewed the December Overtime report.

Mr. Buckley stated that City Hall continues with overtime costs exceeding budget, primarily in Fire (due to employees on medical leave early in the year), EMS (due to rising run volumes) and Police (due to vacancies). It was noted hours for the part-time maintenance person at City Hall were increased to 28 hours per week to help off-set overtime costs in that budget. DPW Bridge Maintenance saw significant added overtime; this is primarily due to openings of the 17<sup>th</sup> Street lift bridge.

#### **Discuss City Manager's Evaluation**

Mr. Buckley stated he felt the discussion at the Work Session Meeting covered his evaluation quite well and he will revise the list of goals to include timelines and parties responsible for implementation and distribute that updated list at a future City Council meeting.

#### **Discuss 2018 Borrowing for Capital Projects**

Mr. Buckley reviewed the list of 2018 Capital Projects to be funded with new General Obligation Debt in 2018. He stated the City will be retiring \$2.2 million in debt principal in 2018. Mr. Buss noted that the number for G.O. principal retirement is larger, as G.O. debt being repaid by the utilities is not included in that total. New G.O. debt proposed for 2018 Projects included in the new Budget is \$2,291,500. Mr. Buckley stated that he would like to have preliminary City Council action on this borrowing on the February 19, 2018 City Council Agenda.

A motion was made by Councilmember Powalisz, seconded by Councilmember Koach,

to recommend that city Council proceed with authorizing new, 10-year debt needed for funding 2018 capital projects. Upon a voice vote, motion carried.

## **Closed Session**
