3. Public Hearing

A. Public hearing for Amendment No. 1 to the Project Plan for TID No. 8 which is proposed to support a building expansion for Riverside Foods, public infrastructure improvements and clearance and remediation of the former gas station site at 2023 Washington Street

Chairman Buckley summarized the projects and expenditures included in proposed Amendment No. 1 for TID No. 8.

Chairman Buckley opened the public hearing. During the first call Ken Swade voiced his support for the amendment. Seeing no one else, Chairman Buckley closed the first call. Seeing no one wishing to comment during the second and third calls, Chairman Buckley closed the public hearing.

However, private lead water replacement assistance would not be available in Amendment No. 1 because it is not included in the Project Plan.

There were no revisions recommended by the Commission. Revisions from the Attorney reviewing the Project Plan are included in the Project Plan provided for the meeting.

Motion to adopt the resolution for Amendment No. 1 to the Project Plan for TID No. 8 and forward to Council.
