They may also be trying to lure you into situations in which they may bring a lawsuit against you or The City.
 - o If confronted by an Auditor "Less is More" is the best strategy. If you don't engage them, they will likely lose interest and leave.
- Increased security throughout departments was discussed to avoid unwanted situations. Possible new measures include signage, security cameras, and additional FOB's.
 - Each department should do a site assessment to identify any vulnerabilities that should be addressed.
